## Emergency Overview

**Physical Description & Colour:** Orange coloured liquid.

**Odour:** Orange fragrance.

### Inhalation:

**Skin Contact:** Irritation is likely. If irritation does occur, flush with lukewarm, gently flowing water for 5 minutes or until chemical is removed.

## Section 6 – Accidental Release Measures

**Accidental release:** This product is sold in small packages, and the accidental release from one of these is not usually a cause for concern.
